

# The Honorable Justice Ben Tennille

Retired Chief Judge of the North Carolina Business Court



## Judicial Background

In January of 1996 Judge Tennille was sworn in as the first Special Superior Court Judge for Complex Business Cases in North Carolina and charged with creating the first state- wide Business Court in the nation. He was the only judge until the fall of 2005, when, on recommendation of the Chief Justice's Commission on the Future of the Business Court, the court's jurisdiction was expanded and two new judges were added. At that time Judge Tennille was appointed Chief Judge of the Business Court. The Business Court is similar to a Federal District Court in that its judges try cases and write opinions designed to create a body of case law involving issues of importance to business and industry in North Carolina. In establishing the court Judge Tennille designed a model paperless court, which employs a free electronic filing system using the

Internet. It was one of the first successful e-filing systems in the country. The Court was one of the first to maintain a website where all the opinions were accessible as soon as they were filed and all pleadings were accessible on the website. The Business Court has received awards for its innovations from the Institute for the Improvement of Civil Justice and Justice Served.

Judge Tennille established his chambers and his courtroom in the new Elon University School of Law. It was the first trial court in the country to be housed in a law school.

Judge Tennille retired from the bench in March 2011.

#### **ABA**

Judge Tennille serves as an Advisor to the Business Law Section and is a Fellow of the American Bar Foundation. As an Advisor he works directly with the Dispute Resolution Committee of the Section. In the fall of 2011 he will begin a four-year term on the Section Council.

In 2002-2003 he served on an American Bar Association Corporate Responsibility Task Force, a panel charged with examining the framework of laws and regulations and ethical principles governing the roles of lawyers, executive officers, and directors. The goal of this Task Force was to design a system of checks and balances to enhance public trust in corporate integrity and responsibility following the Enron and WorldCom failures.

Judge Tennille served as Judicial Division Liaison to the Business Law Section of the ABA from 2006 to 2008.

He was Co-Chair of the Judges Ad Hoc Initiative Committee of the Business Law Section, a committee he helped organize to get judges more involved in Section activities. He also served on the Business Courts Committee and the Business Law Section Institutes and Seminars Board as well as the Business/Corporate Law Advisory Panel for ALI-ABA.

Judge Tennille served as first Chair of the Business and Commercial Courts Committee of the National Conference of State Trial Judges, a committee which provides a forum for the exchange of information, best practices and technology developments among ABA-member judges who are presently sitting on, planning to organize, or simply interested in the concept of courts or divisions of courts dedicated to the trial of business and commercial cases.

Judge Tennille served as Vice President of the North Carolina Bar Association in 2006-2007. He has served on the Technology Advisory Committee, the Dispute Resolution Council, and has been active in the General Counsel Section. He is a regular presenter at CLE programs locally, nationally, and internationally.

## **American College of Business Court Judges**

Judge Tennille helped found the American College of Business Court Judges, served as its first president from 2005 to 2007, and is its President Emeritus. He received the 2006 Judicial Achievement Award from the U.S. Chamber of Commerce for his leadership in establishing business courts in the United States.

Judge Tennille has served on the AEI-Brookings Judicial Education Advisory Board, the American Scientific and Technological Adjudication Resource Center Planning Committee, and the Sedona Conference Advisory Committee and its Working Group on E-Discovery. He served on the Advisory Committee of the Delaware Law Forum. He has been an Adjunct Professor at Wake Forest School of Law, teaching courses in corporate governance.
