Review and Re-launch of P.R.I.M.E. Finance Arbitration Rules

From its inception, it was envisaged that P.R.I.M.E. Finance would offer a specialised forum for finance disputes to be resolved by arbitration. The P.R.I.M.E. Finance Arbitration Rules (**the Rules**) were drafted accordingly.

A review of the Rules was commenced in 2020, with the aim of ensuring that they were fully fit-for-purpose for users, reflecting current best practice in arbitration while preserving and expanding features of particular interest to financial market participants. A draft set of revised Rules was issued for public comment in January 2021. In September 2021, the draft Rules were approved by the P.R.I.M.E. Finance Board. The revised Rules were launched officially in November 2021.

Structure of Review

A two-tier rule structure for the review was established, comprising a Drafting Group and a Consulting Group, with Georges Affaki chairing the Drafting Group and Carolyn Lamm and Heikki Cantell chairing the Consulting Group.
