WORDS OF WELCOME FROM ROBERT G. PICKEL CHAIR OF MANAGEMENT BOARD, P.R.I.M.E. FINANCE FOUNDATION

Crypto, like previous financial innovations, is a source of both opportunity and concern. Our second panel focuses on both aspects in a year that has seen fundamental changes in the regulatory framework for this ever-evolving technology.

Sustainability issues, broadly speaking, are facing headwinds with policy changes in several jurisdictions, notably the United States. Our third panel will consider how the continuing pursuit of sustainability goals can occur even as they are buffeted by these headwinds.

Finally, our last panel of the day will bring together current and former judges who often must deal with the aftermath of volatility, the swings of policy changes, and defense of the rule of law.



We know from experience that fluctuations and volatility in markets often lead to valuation disputes between parties, possible defaults and even insolvencies. While no one wishes these calamities to occur, it is important to be prepared for them. P.R.I.M.E. Finance's efforts to educate and inform judges, policy makers and market participants are important steps to prepare. In the event a dispute is unavoidable, we also offer an alternative to protracted litigation of disputes through our cooperation agreement with the Permanent Court of Arbitration.

I would like to thank all our experts who continue to support P.R.I.M.E. Finance in so many important ways. Most of our speakers today are P.R.I.M.E. Finance experts who have taken time out from their busy schedules to join us. Our expert forums, covering market practice, fintech, sustainability and judicial interests form the backbone of our agenda today. Annette Nazareth serves as Chair of the Integrity Council for the Voluntary Carbon Market, an independent governance body for the voluntary carbon market that has established international standards for high integrity carbon credits. Annette is also Chair of the Urban Institute, a nonprofit research organization that promotes sound social policy and public debate on national priorities. Annette is a financial services lawyer whose career has spanned both the public and private sector. She served as a Commissioner of the US Securities and Exchange Commission and, earlier in her career, as Director of the SEC's Division of Trading and Markets. More recently, Annette was a partner at Davis Polk & Wardwell, where she headed the firm's Washington, DC office and created and led its Trading and Markets practice in its Financial Institutions group.

Jonathan Gilmour Partner, Head of Derivatives & Structured Products at Travers Smith. Jonathan heads up the derivatives and structured products (DSP) practice at Travers Smith LLP with a specialisation in advising clients on carbon trading, green bonds, and other ESG financial instruments. Navigating the complexities of ESG-related financial products, he works closely with industry bodies to develop policy and regulation in this field. Speakers:

Dr. Camelia Bogdan is an independent international arbitrator, P.R.I.M.E. Finance expert, and Certified Chartered FinTech Professional. A former judge on the Bucharest Court of Appeals, she presided over landmark anti-money laundering and asset recovery cases, securing over €350 million for Romania. Her rulings have been recognized by the European Court of Human Rights. A Fulbright Scholar and LL.M. alumna from GWU in Banking, Finance, Corporations, and Securities law, she advises globally on judicial integrity, financial crime, and cross-border enforcement.

Hon. David S. Jones has been a United States Bankruptcy Judge for the Southern District of New York since 2021. He presides over individual and business liquidations and reorganizations, cases under Chapter 15 of the Bankruptcy Code, and adversary proceedings. Previously Judge Jones served as an Assistant United States Attorney in New York for 24 years, at various times heading the government's bankruptcy practice and its civil appellate practice.

Hon. Peggy Kuo was appointed U.S. Magistrate Judge in the Eastern District of New York in 2015. She clerked for the Chief Judge of the D.C. Court of Appeals, was an Assistant United States Attorney in the District of Columbia, then trial attorney and Acting Deputy Chief of the Civil Rights Division Criminal Section at the U.S. Department of Justice. She prosecuted war crimes and crimes against humanity at the United Nations International Criminal Tribunal for the former Yugoslavia in The Hague, including mass rape in Bosnia. Thereafter, Judge Kuo was litigation counsel at Wilmer Hale, Chief Hearing Officer at the New York Stock Exchange, and Deputy Commissioner and General Counsel of the New York City Office of Administrative Trials and Hearings. She graduated from Yale University and Harvard Law School.

KEYNOTE SPEAKER

Ambassador Michael Carpenter

Ambassador Michael Carpenter is Senior Fellow for Transatlantic Affairs at the IISS and leads the Institute's US Foreign Policy and Transatlantic Affairs research program. Michael served in the Biden administration as Special Assistant to the President and Senior Director for Europe at the National Security Council. He was previously US Ambassador and Permanent Representative to the Organization for Security and Cooperation in Europe (OSCE).

From 2017–21, he was Senior Director and then Managing Director of the Penn Biden Center for Diplomacy and Global Engagement at the University of Pennsylvania. From 2015–17, he served in the US Department of Defense as Deputy Assistant Secretary of Defense for Russia, Ukraine, Eurasia, and Conventional Arms Control. Michael has also worked as a Special Advisor to the Vice President and Director for Russia at the National Security Council. Earlier in his career, he was a Foreign Service Officer with the US State Department, serving in Poland, Slovenia and Barbados, as well as many tours in Washington.

He holds a BA in International Relations from Stanford University, and an MA and PhD in Political Science from the University of California, Berkeley.





FIRESIDE CHAT SPEAKERS

Dr. Richard Sandor

Richard L. Sandor (Ph.D., Dr. sc. h. c.) is internationally recognized as "the father of financial futures" and a pioneer in environmental finance. He founded Environmental Financial Products (EFP), which incubated the Chicago Climate Exchange (CCX), setting the stage for modern carbon markets. As Chairman Emeritus of the American Financial Exchange (AFX)—now part of ICE—he helped launch Ameribor, a key credit-sensitive interest rate benchmark.

Dr. Sandor currently serves as the Aaron Director Lecturer in Law and Economics at the University of Chicago Law School and holds honorary professorships at Fudan University and the University of Hong Kong. In fall 2025, he will teach "The Law and Economics of Natural Resources" at the University of Chicago, accessible to students at the Booth Business School and Harris School of Public Policy.

His groundbreaking work in carbon markets earned him recognition from TIME Magazine as both a "Hero of the Planet" and "Hero of the Environment." In 2013, France awarded him the Chevalier de la Légion d'Honneur for his achievements in environmental finance and carbon trading.

Dr. Sandor is a Senior Fellow of the Milken Institute and serves on advisory boards for the Center for Financial Stability, the Digital Dollar Project, and the Ronald Coase Centre at the University of Hong Kong. Previously, he served on the boards of major exchanges and corporations, including CME, ICE, and AEP.

An accomplished author, Dr. Sandor has published extensively on finance and environmental innovation. He holds a B.A. from Brooklyn College, a Ph.D. in Economics from the University of Minnesota, and an honorary doctorate from ETH Zurich.





Paula DiPerna

Paula DiPerna is an author, and strategic global environmental and philanthropic policy advisor. She served formerly as EVP for Recruitment and Public Policy for the Chicago Climate Exchange (CCX), as well as President of CCX-International. She also formerly served as President of the Joyce Foundation, a leading philanthropy in the US, as well as a writer and VP for International Affairs for The Cousteau Society, whose principal was oceans explorer, Jacques-Yves Cousteau.

DiPerna's most recent non-fiction book is <u>Pricing the Priceless: The Financial Transformation to Value the Planet, Solve the Climate Crisis</u>, and Protect Our Most Precious Assets, named to the Financial Times "Best Summer Reads: Economics" roster in 2023. Her novel, *The Discoveries of Mrs. Christopher Columbus* has been published in the US, Turkey, Germany and Portugal.

DiPerna is also a columnist for Environment magazine and ESG Review.

Currently, DiPerna serves as Special Advisor to CDP, as well as on the Distinguished Advisory Board of the Integrity Council for the Voluntary Carbon Market (ICVCM).

Ms. DiPerna was named a Visiting Fellow at Civic Exchange, Hong Kong, focused on emerging issues in Asia and a Resident Fellow at the Bellagio Center of the Rockefeller Foundation, to further her writing on environmental finance.

Ms. DiPerna is a member of the Women's Forum of New York, the NY Economic Club, and the Council on Foreign Relations among others.

Mission

P.R.I.M.E. Finance is the Panel of Recognised International Market Experts in Finance, an independent, not-for-profit foundation based in The Hague and established in the wake of the 2008 global financial crisis. Its mission is to reduce legal uncertainty and systemic risk by ensuring that the requisite expertise is available to anticipate and address any disputes that may arise in the financial markets. P.R.I.M.E. Finance's traditional focus has been on issues arising in relation to industry standards (e.g., documentation, market practices, valuations) for derivatives and other complex financial products. Now, with the growing interest in areas such as sustainable finance and financial technology, P.R.I.M.E. Finance also aims to anticipate how disputes may arise in these and other emerging areas of the financial markets and consider how it can best address them.

Activities

P.R.I.M.E. Finance's core activities are:

- I. building capacity in developed and developing countries to better understand capital markets and financial contracts through judicial training and education and outreach to market participants and regulators, working with other organisations that share this focus;
- II. dispute resolution services, including arbitration, mediation and facilitating the engagement of experts to serve as expert witnesses or advisers. Arbitrations under the P.R.I.M.E. Finance Arbitration Rules are administered by the Permanent Court of Arbitration;
- III. providing continuing education through conferences and webinars; and
- IV. maintaining a central database of international precedents and source materials, with the support of LexisNexis.

The PCA is the world's oldest arbitral institution, with over a century of experience in administering complex international proceedings. P.R.I.M.E. Finance joined forces with the PCA in 2015, thereby combining the subject matter expertise of its Panel of Experts with the PCA's efficiency in administering arbitrations. As a result, arbitrations and mediations under the P.R.I.M.E. Finance Arbitration and Mediation Rules are administered by the PCA, and parties to complex financial transactions have access to an efficient arbitration and mediation mechanism to resolve their disputes. While the filing address for notices of arbitration and mediation is with the PCA at its Peace Palace headquarters in The Hague, arbitrations may take place anywhere in the world, and may be facilitated by the PCA's host country agreements with a number of its Contracting Parties.

In addition, under the P.R.I.M.E. Finance Arbitration and Mediation Rules, the Secretary-General of the PCA acts as appointing authority for P.R.I.M.E. Finance in cases where the parties cannot agree on the appointment of arbitrators. The Secretary-General of the PCA serves on the P.R.I.M.E. Finance Advisory Board.


