#### **11:30 – 12:30 Arbitration Focus**

This session will explore live topics and current trends impacting the arbitration of international finance disputes. The panel will also consider the advantages of the P.R.I.M.E. Finance Arbitration Rules for the resolution of financial disputes.

#### **Moderator:**

Georges Affaki Professor of law at the University of Paris, Judge at the Qatar International Court, Chartered Arbitrator and a member of the ICSID Panels of Arbitrators and Mediators. He has served as a member of the ICC International Court of Arbitration. He sits on the Board of Directors of the Saudi Center for Commercial Arbitration and is consistently listed by Chambers and Partners amongst the Most in Demand Arbitrators. He chaired the revision of the P.R.I.M.E. Finance Arbitration Rules and co-chaired the ICC Task Force on Financial Institutions and International Arbitration. He led or participated in several law reforms in transition economies. In 2019, he was appointed Foreign Trade Counselor of France by a Decree of the Prime Minister of France. He is a P.R.I.M.E. Finance Expert.

#### **Speakers:**

Hannah Ambrose Partner, Global Arbitration & Public International Law, Herbert Smith Freehills LLP. She has acted as counsel in ad hoc commercial arbitrations and proceedings under the auspices of major arbitral institutions, including the ICC, LCIA and SCC. She has acted as counsel on a number of investment treaty claims, and advises clients on investment structuring and a range of other PIL matters. She has advised banks, financial institutions and funds on both commercial arbitration and investment treaty issues, including a major Asian bank in an UNCITRAL arbitration on the recovery of its investment in a derivative-linked securities fund.

He was Head of Chambers at 3VB from 2016 to 2022. Adrian specialises in commercial litigation and advisory work, both domestic and multinational. His litigation practice includes banking and financial services, commercial disputes, corporate insolvency and restructuring, professional negligence involving solicitors, accountants and valuers, civil fraud and asset tracing, restitution, off-shore trusts, forum disputes, injunctions, freezing and search orders and other interim remedies. He is also instructed in arbitrations in the same fields. He has twice been named 'Banking silk of the Year' by Chambers & Partners. He is currently nominated for Financial Services and Insurance Silk of the Year 2024 by The Legal 500. In 2017, he was invited to join the P.R.I.M.E Finance panel of experts.

Prof. Loukas Mistelis International Arbitration Partner with Clyde & Co LLP, based in London, and the Clive Schmitthoff Professor of Transnational Commercial Law and Arbitration at the Centre for Commercial Law Studies, Queen Mary University of London. Loukas is an acknowledged authority on international dispute resolution and investment treaty law. In 2006 he was listed as one of the "leading lights in international arbitration" and since 2007 he is listed on the Who's Who Commercial Arbitration and since 2017 as Global Thought Leaders in International Arbitration. He has been listed in the Legal500 International Arbitration Powerlist since its inaugural year (2019). He regularly sits as an arbitrator and acts as counsel and expert in arbitration proceedings. His substantial arbitration experience covers ad hoc and most major arbitral institution and subject matters included foreign investment, finance contracts, syndicated loans, transport contracts, aviation, privatization, construction and infra-structure projects, defence contracts, mining, administration of natural resources, real estate, mining, and oil and gas transactions. #### 13:30 – 14:30 Fiduciary Duties and Sustainability

Sustainable finance continues to evolve with a recent focus on regulation, disclosure, anti-greenwashing and labelling regimes. Sources of finance from private and public sources, and blended finance models combining the two, have also been topical. There has been attention on the concept of fiduciary duty and legal and regulatory constraints to investing for environmental and social impact. The panel will discuss recent trends in this busy area.

#### **Moderator:**

Ida Levine Principal with Two Rivers Associates Limited consulting on public policy, strategy and governance. She is a Non-Executive Director of the Impact Investing Institute and serves on the Management Board of P.R.I.M.E. Finance Foundation in The Hague. Ida also sits on the Financial Markets Law Committee and the Advisory Board of the UCLA Institute of Carbon Management. She was a founding Director of the UK Investor Forum. Ida is a former Board Director and Senior Vice-President and Senior Counsel of Capital Group and founded its Public Affairs function in Europe. Previously, she was European Counsel with JP Morgan Investment Management and a Partner at the international law firm Jones Day (London and New York). She is a P.R.I.M.E. Finance Expert.

#### **Speakers:**

Heikki Cantell General Counsel, Secretary General, and Head of Legal Department of the Nordic Investment Bank. He has previously been General Counsel of the Council of Europe Development Bank, Head of the Paris branch of Finnish law firm Heikki Haapaniemi, and a Legal Counsel for the Finnish Cultural Foundation. During this period, Samallie worked with International Swaps and Derivatives Association, Inc. (ISDA) to



increase awareness of ISDA's mandate across Africa. Prior to working in development finance, Samallie was the Global Head of the Securitisation Regulatory Policy and Advisory Group at Deutsche Bank. Samallie has also worked at Clifford Chance in London and Ashurst in Sydney. Ms Kiyingi has a first-class Bachelor of Law degree from the University of Technology, Sydney, and a Masters in Law and Finance from the University of London. She is a P.R.I.M.E. Finance Expert.

#### 14:30 - 15:30 Fintech: Geopolitical Dimensions of Cross-Border Payments

This session will consider how new means of cross-border payments, in particular using digital assets, interact with geopolitical issues such as sanctions and national security. The panel will also consider the legal nature of such assets in a cross-border context

#### **Moderator:**

**David Geen** Senior Technical Advisor, Legal Directorate of the Bank of England. His role includes co-ordinating the Directorate's coverage of FinTech issues. He was previously the Bank's Deputy General Counsel for Central Banking and prior to that held various divisional management positions within the Legal Directorate. Before joining the Bank of England in 2016, Mr. Geen was General Counsel of the International Swaps and Derivatives Association (ISDA), which he joined in 2006. He held that post through the financial crisis and through the post-crisis changes to derivatives markets. Before joining ISDA, Mr. Geen was an Executive Director and Senior Counsel at Goldman Sachs in London, where he variously headed and co-headed the London derivatives team within the Legal Department, covering OTC derivatives sales and trading as well as synthetic credit and CDO desks. Mr. Geen started his legal career at Baker & McKenzie in London, becoming a partner in 1997. He is a graduate of Warwick University in the UK. He is a P.R.I.M.E. Finance Expert.

#### **Speakers:**

**Professor Sarah Green** was Law Commissioner for Common and Commercial Law at the Law Commission of England and Wales from 2020 to 2024. During that time, her law reform work included the Electronic Trade Documents Act 2023, Advice to Government on Smart Contracts, updating the Arbitration Act 1996, scoping reforms to the law on Intermediated Securities, and drafting guidance and a bill to ensure that English law is well-suited to accommodate Digital Assets. In 2023, she won both the International Chamber of Commerce's Award for the Individual Who Has Made the



Greatest Contribution to the Digitalisation of Trade and the Outstanding Achievement Award at the British Legal Technology Awards. In 2022, she was placed on the Women in Fintech Power List and on Bloomberg's "Who to Watch" Crypto List. Sarah is now Head of Digital Assets and Trade Finance at D2 Legal Technology, Professor of Private Law at the University of Bristol and a member of T3i Partner Network. Sarah also sits on the UK Jurisdiction Taskforce, LawTechUK, The Digital Commonwealth, LegalUK, and the Trade Digitalisation Taskforce, as well as being an advisor to the APPG on Blockchain Technologies. She was previously Professor of the Law of Obligations at the University of Oxford and a software consultant at Accenture. She has written books and articles on subjects such as blockchain, smart contracts, digital assets and intermediated securities, and her work has been cited extensively across several jurisdictions in appellate courts, Parliament and US Congress.

**Dr. Scott Farrell** Strategic Counsel, King & Wood Mallesons. Scott is an Adjunct Professor at the UNSW Sydney Law School, serves on the Payments System Board of the Reserve Bank of Australia, and chairs the global ISO technical committee developing standards for blockchain technologies. Scott led the Australian Government Reviews which designed and developed Australia's consumer data right framework and modernised its payments regulation. He is a P.R.I.M.E. Finance Expert.

**Matthew Elderfield** has worked as a senior banker and financial regulator in the UK, EU and Bermuda. He serves on the Boards of Directors of Rabobank and the British Business Bank, and as Chairman of Fnality UK. Matthew was a member of the Management Board of Nordea, most recently as Chief Risk Officer, and also worked at Lloyds Banking Group and ISDA. Matthew was Deputy Governor of the Central Bank of Ireland and also Chief Executive of the Bermuda Monetary Authority. He is a P.R.I.M.E. Finance Expert.

Mr. Bauman is a former chairman of the International Swaps and Derivatives Association and member of ISDA's board of directors. Mr. Bauman has been an active representative for the derivatives industry, speaking in numerous forums including testimony before U.S. Congressional committees, the Financial Accounting Standards Board, and international regulatory bodies. He received his B.A. from Rutgers University where he was a Henry Rutgers Scholar, and his Master of Public Administration from the Wharton School at the University of Pennsylvania. Carolyn Jackson Partner, Financial Markets and Regulatory practice at Katten Muchin Rosenman UK LLP. #### **KEYNOTE SPEAKER**

#### The Hon. Mr Justice (Andrew) Henshaw

Mr Justice Henshaw has been a judge of the Commercial Court since 2019, and became Judge in Charge of the court in September 2024. He also sits in the Administrative Court, Crown Court and Court of Appeal (Criminal Division). Prior to appointment, he practised as a litigation solicitor at Linklaters from 1984 to 2000, becoming a partner in 1994. He then moved to the Bar and practised from Brick Court Chambers from 2000 to 2019, specialising in commercial and banking/derivatives litigation and arbitration, public and EU law, becoming a QC in 2013. He has been involved in banking and financial services cases throughout his career, including multi-national litigation arising from the collapse of the Maxwell empire, defending derivatives cases brought against US investment banks, and litigation over complex products such as CDOs. He appeared for the UK government in EU Court of Justice cases about financial market abuse, and advised/represented the FCA on a regular basis.

#### Mission

P.R.I.M.E. Finance is the Panel of Recognised International Market Experts in Finance, an independent, not-for-profit foundation based in The Hague and established in the wake of the 2008 global financial crisis. Its mission is to reduce legal uncertainty and systemic risk by ensuring that the requisite expertise is available to anticipate and address any disputes that may arise in the financial markets. Its goal in doing so is to foster financial market stability and confidence in, and a more settled and authoritative body of law for, world finance.

P.R.I.M.E. Finance's traditional focus has been on issues arising in relation to industry standards (e.g., documentation, market practices, valuations) for derivatives and other complex financial products. Now, with the growing interest in areas such as sustainable finance and financial technology, P.R.I.M.E. Finance also aims to anticipate how disputes may arise in these and other emerging areas of the financial markets and consider how it can best address them.

#### **Activities**

P.R.I.M.E. Finance's core activities are:

- I. building capacity in developed and developing countries to better understand capital markets and financial contracts through judicial training and education and outreach to market participants and regulators, working with other organisations that share this focus;
- II. dispute resolution services, including arbitration, mediation and facilitating the engagement of experts to serve as expert witnesses or advisers. Arbitrations under the P.R.I.M.E. Finance Arbitration Rules are administered by the Permanent Court of Arbitration;

#### Cooperation with Permanent Court of Arbitration

The PCA is the world's oldest arbitral institution, with over a century of experience in administering complex international proceedings. P.R.I.M.E. Finance joined forces with the PCA in 2015, thereby combining the subject matter expertise of its Panel of Experts with the PCA's efficiency in administering arbitrations. As a result, arbitrations and mediations under the P.R.I.M.E. Finance Arbitration and Mediation Rules are administered by the PCA, and parties to complex financial transactions have access to an efficient arbitration and mediation mechanism to resolve their disputes. While the filing address for notices of arbitration and mediation is with the PCA at its Peace Palace headquarters in The Hague, arbitrations may take place anywhere in the world, and may be facilitated by the PCA's host country agreements with a number of its Contracting Parties.

In addition, under the P.R.I.M.E. Finance Arbitration and Mediation Rules, the Secretary-General of the PCA acts as appointing authority for P.R.I.M.E. Finance in cases where the parties cannot agree on the appointment of arbitrators. The Secretary-General of the PCA serves on the P.R.I.M.E. Finance Advisory Board.

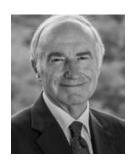
