WORDS OF WELCOME FROM ROBERT G. PICKEL, CHAIR OF MANAGEMENT BOARD, P.R.I.M.E. FINANCE FOUNDATION

Dear all,

Welcome to Amsterdam, a new place for P.R.I.M.E. Finance in a country very familiar to us!

Those of us who have joined our events in The Netherlands in the past know that we usually convene in The Hague, about an hour south of here on the train. Time and again the beauty of the Peace Palace drew us to Carnegieplein for an event we held annually in the middle of winter, until COVID turned the world upside down. We again convened in The Hague in 2023 in the warmth of summer, a change that was well-received by all in attendance.

So why Amsterdam this year? One word: ISDA. Or if you prefer six words: the International Swaps and Derivatives Association. ISDA is an organisation that many of us at P.R.I.M.E. Finance, and many of you attending today, have been closely associated with over the years. | | The International Swaps and Derivatives Association, now celebrating its 40th year, is holding its annual meeting in Amsterdam in the days preceding this conference. The annual meeting is the premier event for the derivatives world. This panel will bring together several attendees of the annual meeting to share their observations on developments in the derivatives market and financial markets more generally. <u>Moderator:</u> Rick Grove is CEO of Rutter Associates, a financial markets consulting firm active in the Americas, Asia and Europe. He has served as CEO of ISDA and worked in sales and trading at Bank of America and Paribas Capital Markets. Rick began his career as a lawyer with Cravath in New York and London. Rick has acted as a consultant and expert on disputes being mediated, arbitrated or litigated in Hong Kong, London, New York, Shanghai, Singapore, Stockholm and Taipei. He is a P.R.I.M.E. Finance Expert and Member of its Advisory Board. <u>Speakers:</u> Ian Cuillerier is a Partner at White & Case LLP, New York. His practice focuses on derivatives and structured products. He regularly advises banks, dealers, funds, sovereigns and multilateral development banks as well as corporate and commercial |



users of derivatives in structured transactions, and in compliance and regulatory matters. Mr. Cuillerier negotiates, documents, structures and develops derivatives in a broad spectrum of complex physical and financial transactions including derivatives-linked securities, commodity transactions (including energy, metals, oil and gas, and emission credits), bespoke structured products and rate, credit, fixed income and currency derivatives. He also regularly negotiates prime brokerage, repurchase/reverse repurchase and securities lending arrangements. In addition, he counsels domestic and foreign entities in the laws and regulations applicable to derivatives in the United States, including the implications of the Dodd-Frank Act. Mr. Cuillerier is admitted to practice in New York. He graduated from the Richard Ivey School of Business Administration of the University of Western Ontario with an honors business administration degree in 1991. In 1995, he graduated from the Faculty of Law of McGill University with BCL and LLB degrees. He is a P.R.I.M.E. Finance Expert.

Emma Dwyer has specialised in derivatives and structured finance for more than 25 years and joined Fieldfisher as a partner in May 2024, having previously led the derivatives and structured finance team at Allen & Overy (now A&O Shearman). Emma has a deep understanding of derivative products and is active across the markets that they are used in. Since the financial crisis, Emma has had a particular focus on EMIR and other regulation impacting derivatives and her work includes advising clients on its implementation and interpretation and working with market infrastructure providers, such as central clearing houses and trade repositories, and trade associations in this space. Emma's work also includes advising on and helping to structure derivatives in complex structured financings, with particular expertise in credit related transactions and FX. Emma continues to work across the spectrum of the derivatives industry at Fieldfisher as highlighted by some of the submitted examples.

More widely in the derivatives industry, Emma is the author of a chapter on client clearing arrangements in the recently published Clearing OTC Derivatives in Europe and a chapter on UK Derivatives and Commodities Markets in Financial Markets and Exchanges Law, each published by Oxford University Press. Prof. Yael Diamant

Prof. Yael Diamant works as Senior Legal Counsel at De Nederlandsche Bank N.V and is a Professor of Financial Networks and European Property Law at Tilburg University. Her research focuses primarily on the interface of property law and financial regulatory law. Relevant topics in this field are the safeguarding of clients' funds by financial enterprises and the legal aspects of the digital euro. Previously, she worked as a lawyer at NautaDutilh N.V. and obtained her PhD on financial collateral arrangements from Tilburg University.



OPENING REMARKS

Dr. Hab. Marcin Czepelak

Dr. Hab. Marcin Czepelak is the Secretary General of the Permanent Court of Arbitration (PCA). Prior to his election as Secretary General of the PCA, Dr. Hab. Czepelak was ambassador of the Republic of Poland to the Kingdom of the Netherlands and permanent representative to the Organization for the Prohibition of Chemical Weapons. He represented the Republic of Poland at various international fora, including the Committee on the Election of the Prosecutor of the International Criminal Court, the Working Group on the Rules of Procedure of The Hague Conference on Private International Law, and the First Committee of the United Nations General Assembly.

Dr. Hab Czepelak is professor of private international law at Jagiellonian University in Kraków (Poland). He completed his habilitation and doctorate at Jagiellonian University and has published widely in the fields of private international law, international litigation, and arbitration.

He is fluent in English, Polish, German and French and has good knowledge of Dutch and Spanish.

Cooperation with Permanent Court of Arbitration

The PCA is the world's oldest arbitral institution, with over a century of experience in administering complex international proceedings. P.R.I.M.E. Finance joined forces with the PCA in 2015, thereby combining the subject matter expertise of its Panel of Experts with the PCA's efficiency in administering arbitrations. As a result, arbitrations and mediations under the P.R.I.M.E. Finance Arbitration and Mediation Rules are administered by the PCA, and parties to complex financial transactions have access to an efficient arbitration and mediation mechanism to resolve their disputes. While the filing address for notices of arbitration and mediation is with the PCA at its Peace Palace headquarters in The Hague, arbitrations may take place anywhere in the world, and may be facilitated by the PCA's host country agreements with a number of its Contracting Parties.

In addition, under the P.R.I.M.E. Finance Arbitration and Mediation Rules, the Secretary-General of the PCA acts as appointing authority for P.R.I.M.E. Finance in cases where the parties cannot agree on the appointment of arbitrators. The Secretary-General of the PCA serves on the P.R.I.M.E. Finance Advisory Board.


