The PCA is celebrating its 125th anniversary in 2024, having been established by the Convention for the Pacific Settlement of International Disputes concluded at The Hague in 1899, during the first Hague Peace Conference.



Helen Dodds, together with co-authors Maria Tymofienko, Kseniia laremych and Tetyana Antsupova, published a report under the aegis of the British Institute of International and Comparative Law (BICCL) in April. The report, "Unlocking Investment in Ukraine", was commissioned by the UK Ministry of Justice and considers how Ukraine can encourage international commercial investment by creating confidence in its legal system among investors, identifying issues and proposing solutions.
